79/24 Westmorland and Furness Councilor Report

The following report from Westmorland and Furness Councilor Cllr Michael Hanley was presented to the meeting.

1 Community and Environment Scrutiny Committee 28.10.24

Expected increase of 520% in house building with 659 new affordable homes. Also 450 new sites, also WAFC plans to restart building council houses in the future.

2 Housing Workshop 14.10.24

There is an urgent need to review the Right to Buy (council and housing association properties).

3 Eden Locality Board 2.10.24

Over the next 2-3 months £2.2 million will be spent in WAFC on increasing the number of electric vehicle chargers.

4 Community and Environment Scrutiny Committee 8.10.24

Call-in regarding the proposed closure of the library in Ulverston and the transfer to the Coronation Hall. Verdict: the consultation was not fair and advised repeating this. The cabinet subsequently did not accept this verdict.

5 Alston and Fellside Place Action Group Inaugural Meeting

First meeting of this group to promote development in this area. Markus Campbell-Savours (MP), Dave Allen (PCC) and the Cumbria High Sheriff attended. Loss of cash points on Alston Moor, the community buy-out of the Miners Arms pub in Nenthead, the High Mill project in Alston were discussed.

82/24 Highways and Land Matters

82.1 Langwathby Traffic and Parking Issues

82.1.1 Eden Straits - Speeding Traffic

Reported that Highways will review the current signage and road markings, throughout the village, with the intention of making improvements to ensure speeds remain low and within the 30mph.

82.1.2 Salkeld Road - Speeding Traffic.

Reported that, in the first instance, Highways will collect traffic data; this will then allow them to identify what the 85th percentile speed and mean speed is, the volumes of traffic and any peak times where motorists are increasing speed. Once in receipt of this data Highways will be able to advise what action needs to be taken.

Highways will also liaise with the Development Team, because usually, when a new housing estate is constructed, such as by Hopes Garage, a speed restriction extension is included in the planning conditions.

The Parish Council also asked that the possibility of installing illuminated, digital, speed awareness signs be looked into, as a traffic calming measure; even, if initially, as a temporary measure.

Highways confirming that they will respond, in a couple of months' time, when further data is available.

82.1.3 Maypole Junction Safety.

Reported that a request had been made to Highways to look into the road markings and signage at this junction with a view to reducing traffic speed, leading to ensuring that traffic stopped at this junction, thus improving safety.

82.1.4 Low Mill Entrance Junction

Reported that a request had been made to Highways to look into the road markings and signage at this junction, which currently are seen as inadequate.

82.1.5 Langwathby One Way One-Way Traffic Restriction

Highways had confirmed that the intention was, for the implementation of this, initially temporarily, one-way system,, to commence in January 2025, subject to weather conditions.

82.2 Edenhall Flooding Issues - Sports Field Area

Reported that work was currently in hand to improve the drainage in this area.

82.4 Langwathby- Salkeld Road – Jetting of Concrete Drains

Reported that this issue had been reported' yet again, to Highways. The cause of delay in resolving the problem appears to be a shortage of staffing and equipment.

82.5 Langwathby – Eden Straits – Improving the River View from Seat.

This pruning will take place on the 22nd January 2025
