314 Update Reports

- **1 Appointment of Parish Clerk** Sarah Fairlamb appointed from 1st March 2011. A two month overlap with Ray Wager has been arranged to ensure a smooth handover. Ray to complete internal accounts and audit and to assist with elections and annual meeting.

- **3 Footpath to sports field** Highways and Infrastructure Dept unable to resolve the problems associated with acquisition of land for the footpath. The scheme to be postponed from this year's programme and hopefully to be resurrected in next year's programme (2011/12 from April onwards).
